APPEALS - Concurrent Findings - Chieftaincy Matters - Concurrent findings of fact of the two lower courts - Amply supported by evidence - Whether Supreme Court will dismiss the findings. *Otitoju v. Gov. of Ondo State*. P.77

APPEALS - Error of Court of Appeal - In holding that objection to admissibility of document ought to be pleaded - Where the error occasioned no miscarriage of justice - Whether judgment will be interfered with. *Oseni v. Dawodu* . P. 51

APPEALS - Forgery Allegation in Civil Matters - Land Dispute - Allegation by the defendant that a conveyance was forged - Concurrent finding of the two lower courts that the forgery was now established - Upheld by the Supreme Court. *Tewogbade v. Obadina*. P. 1

APPEALS - Upholding of Findings - Land Dispute - Court o upholding of trial court's judgment in Plaintiffs' favour - justifiable. *Ige v. Akoju*. P. 37

APPEALS - Upholding Trial Court's Findings - By the Court of Appeal - That an alleged separate town is a quarter and has no paramount ruler - Whether correct. *Otitoju v. Gov. of Ondo State*. P. 1

CHIEFTAINCY MATTERS - Paramount Ruler - Claim that a mere quarter is a distinct town - With its own paramount ruler - When the two lower court's findings to the contrary - Will be upheld by the Supreme Court. *Otitoju v. Gov. of Ondo State*. P. 77
