**ACTIONS** - Cause of action - Definition - How properly defined and explained (H 3) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**ACTIONS** - Cause of action - In the present case - When it arose - With a view to determining the limitation period (H 4) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**ACTIONS** - Fresh action - Declaration of title - Anchored on a previous judgment - Must be proved afresh - And the action will fail upon a successful defence of res judicata (H 7) Ikeni v. Efamo p. 1603

**ACTIONS** - Limitation of action - Statute bar - Where the action was filed - After the period limited by law had expired - The action is statute barred - As in the present case (H 5) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**ACTIONS** - Locus standi - The plaintiff in this case - Has the standing to sue - As he has sufficient interest in the subject matter (H 4) Ajayi v. Jolayemi p. 1689

**ACTIONS** - Statute bar - Effect - A statute barred action - Cannot be maintained - Or properly instituted - And should be struck out from the trial court (H 6) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**APPEALS** - Competence - Leave to appeal - Grounds of appeal - Where some of the grounds are of pure law - The appeal is competent without leave of court (H 2) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**APPEALS** - Evidence - Document - That was discountenanced by the trial judge - In respect of which there was no appeal - Cannot be directly or surreptitiously looked at by the appellate court (H 4) Bank of the North Ltd v. Yau p.1561

**APPEALS** - Grounds of appeal - In determining whether it alleges an error of law or fact - It is always relevant and crucial - To construe the ground

together with its particulars (H 1) P.N. Uddoh Trading Co. Ltd v. Abere p. 1713

**APPEALS** - Issue - Which does not relate to any of the grounds of appeal - Such issue cannot be argued and is incompetent (H 5) Odu v. State p. 1551

**APPEALS** - Judgment - Decision - Based on an erroneous premises - On a matter that goes to the root of the controversy - Cannot be allowed to stand (H 2) Bank of the North Ltd v. Yau p.1561

**APPEALS** - Preliminary objection - Raised against the grounds of appeal - Are untenable - As they do not offend the Rules of the Court (H 3) Ajayi v. Jolayemi p. 1689

**ARBITRATION** - Arbitrators award - Interest awarded by trial court - On the award - Was without jurisdiction (H 5) Ras Pal Gazi Const. Ltd v. F.C.D.A. p. 1651

**ARBITRATION** - Conversion to courts judgment - The court has no jurisdiction - To convert the award into its judgment - Rather it will enter it as a judgment - And give effect to it - In the absence of a challenge (H 3) Ras Pal Gazi Const. Ltd v. F.C.D.A. p. 1651

**ARBITRATION** - Judgment - Arbitrators award - Once filed in court - Has the force and effect of a judgment (H 1) Ras Pal Gazi Const. Ltd v. F.C.D.A. p. 1651

**ARBITRATION** - Jurisdiction of court - Is to give leave to enforce the award as a judgment - And not to tamper with it in any other way (H 4) Ras Pal Gazi Const. Ltd v. F.C.D.A. p. 1651

**ARBITRATION** - Settlement out of court - Differs from an arbitrators award - Because the award immediately becomes binding on the parties

**BANKING** - Bill - Notice of dishonour - Reasonable time - A delay in giving notice extending for a period of nearly one year - Without any satisfactory explanation - Is unreasonable (H 3) Bank of the North Ltd v. Yau p.1561

**CRIMINAL PROCEDURE** - Alibi - Failure to investigate - Consequence - Where there is positive evidence which cancels the alibi - Failure to investigate the alibi - Would not be fatal to conviction (H 1) Odu v. State p. 1551

**CRIMINAL PROCEDURE** - Alibi - Onus - Of establishing the defence - Is on the accused - Even if the police has failed to investigate the assertion (H 2) Odu v. State p. 1551

**CRIMINAL PROCEDURE** - Proof beyond reasonable doubt - Where the evidence against each of the accused persons is overwhelming - And there is no special ground which would establish any doubt as to their guilt - Prosecution has proved its case beyond reasonable doubt (H 4) Odu v. State p. 1551

**ESTOPPEL** - Cause of action estoppel - Defence of - What the defence connotes (H 2) Ikeni v. Efamo p. 1603

**ESTOPPEL** - Cause of action estoppel - How it arises (H 1) Ikeni v. Efamo p. 1603

**ESTOPPEL** - Issue estoppel - Identity of parties - Where there are several parties in the previous suit - It is sufficient that those of the parties who were necessary parties to the issue in the previous suit - Are the same as in the latter suit (H 9) Ikeni v. Efamo p. 1603

**ESTOPPEL** - Issue estoppel - Requirements - What is required for the

doctrine to be applicable (H 5) Ikeni v. Efamo p. 1603

**ESTOPPEL** - Issue estoppel - Where a plea of cause of action estoppel cannot be raised - A party can still plead that the other party is precluded from contending the contrary of any precise point - Which has once been distinctly put in issue - And determined directly and distinctly in the first action (H 3) Ikeni v. Efamo p. 1603

**ESTOPPEL** - Nature and effect - Of admissions and the plea of estoppel (H 7) Bank of the North Ltd v. Yau p.1561

**ESTOPPEL** - Statements - Which have been acted upon by another to his detriment - In the belief that the statements were true - The maker thereof is absolutely estopped to contradict or deny the truth of such statements (H 6) Bank of the North Ltd v. Yau p.1561

**EVIDENCE** - Estoppel - Admission of liability by a party - That party is estopped from denying such admission (H 8) Bank of the North Ltd v. Yau p.1561

**JUDGMENTS** - Error - Appellate court - Inherent power - To correct judgment - There is such power in the Supreme Court to correct its judgment or that of the lower court - In order to avert mischief (H 1) Bank of the North Ltd v. Yau p.1561

**JUDGMENTS** - Res judicata - Counter claim - Where the judgment in a previous case could not avail the plaintiff - Dismissal of the defendant's counter claim - On the ground of res judicata - Is erroneous (H 10) Ikeni v. Efamo p. 1603

**JURISDICTION** - Cause of action - Which arose before the jurisdiction of the court is ousted - Any further hearing of the matter is null and void - Because any decision it makes amounts to nothing (H 5) Isaiah v. Shell Petroleum Ltd. p. 1631

**JURISDICTION** - Issue of jurisdiction - When it can be raised - The issue of jurisdiction can be raised at any stage of any proceedings - Even in an appeal before the Supreme Court (H 1) *Isaiah v. Shell Petroleum Ltd.* p. 1631

**JURISDICTION** - Issue of jurisdiction - When it should be considered - It is important to consider the issue of jurisdiction first - Because where a court exercises a jurisdiction it does not possess - Its decision amounts to a nullity (H 2) *Isaiah v. Shell Petroleum Ltd.* p. 1631

**JURISDICTION** - What it means - And how it can be limited (H 6) *Isaiah v. Shell Petroleum Ltd.* p. 1631

**LANDLAW** - Fresh suit - Declaration of title - Obtained in a Native Court suit without a plan - The plaintiff is entitled to now seek a declaration tied to a plan (H 6) *Ikeni v. Efamo* p. 1603

**LANDLAW** - Reallocation of Land - The conversion of a customary title - To a right of occupancy under the Land Use Act - Does not amount to a reallocation of Land - In contravention of an interlocutory injunction by the Court of Appeal - As in this case (H 1) *Kokoro-Owo v. Lagos State Govt.* p. 1671

**MURDER** - Self Defence - In a hand to hand fight - Where the accused used a knife and stabbed the other who later died - Self defence is negated (H 3) *Odu v. State* p. 1551

**ORDERS** - Interlocutory injunction - The Court cannot make an order against a person - Who is neither a party nor a privy - To proceedings before it - And its order did not affect the plaintiff's land - In this case (H 2) *Kokoro-Owo v. Lagos State Govt.* p. 1671

**PARTIES** - Necessary parties - As there was no complaint made - Against

the Governor in this case - It would have been wrong to join him - In the proceedings (H 2) Ajayi v. Jolayemi p. 1689

**PETROLEUMLAW** - Jurisdiction - Oil spillage - Spillage and Pollution which occurred in the course of repair of indented pipeline - Is a matter arising from - Mines and minerals including oil fields and oil mining - And falls within the exclusive jurisdiction of the Federal High Court - As provided under s. 230 (1) (a) of Decree No. 107 (H 4) Isaiah v. Shell Petroleum Ltd. p. 1631

**PETROLEUMLAW** - Mining operations - Construction and maintenance of an oil pipeline - By a holder of oil prospecting licence - Is an act pertaining to mining operations (H 3) Isaiah v. Shell Petroleum Ltd. p. 1631

**PLEADINGS** - Reliefs sought - Where they are claimed per writ of summons - And defendant fails to object to the irregularity before pleading to it - And there is no miscarriage of justice - The issue cannot be raised on appeal (H 5) Ajayi v. Jolayemi p. 1689

**RES JUDICATA** - Issue estoppel - Distinct causes of action - Where the causes of action in the earlier and latter proceedings are distinct - And separate as in the present case - What is relevant is issue estoppel (H 4) Ikeni v. Efamo p. 1603

**RES JUDICATA** - Plea of estoppel - Conflicting judgments - Where there are two or more conflicting judgments - It is the latest in time that constitutes res judicata (H 8) Ikeni v. Efamo p. 1603

**STATUTES** - Interpretation - S.15 Kwara State Chiefs Edict No.3 of 1998 - Does not apply - Where the issue is the appointment of a member of a Traditional Council - As in this case (H 1) Ajayi v. Jolayemi p. 1689

**WAIVER** - Implied waiver - Conduct - Waiver may be implied from conduct (H 5) Bank of the North Ltd v. Yau p.1561
